"One in four patients over the age of 65 admitted to hospital as an emergency experiences delirium – a state of mental confusion that starts suddenly and is usually triggered by a physical condition. Delirium is highly distressing for patients and their carers and is known to be linked to long-term cognitive impairment and increased risk of death. However, it remains mostly undetected." The Landmark Study, University of Edinburgh March 2022

"Delirium is marker of acute illness and is increasingly recognised as being a condition linked to the presentation of Covid-19, particularly in older people. This presents new challenges in terms of recognition and management." **British Geriatric Society**

"One in eight hospital patients is affected by delirium, which can make people unsteady on their feet, increases the risk of developing dementia and can result in longer hospital stays or admission to a care home." NHS England

"Older people (and people with cognitive impairment, dementia, severe illness or a hip fracture) are more at risk of delirium. About 20–30% of people on medical wards in hospital have delirium. Between 10% and 50% of people who have surgery go on to develop delirium, varying on different types of surgery and settings. In long term care settings, its prevalence is under 20%." NHS England

"Older people are at the greatest risk from Covid-19. If infected they may present with or develop a delirium. However, delirium is not exclusive to older people and may well be seen in any patient with severe infection, adult respiratory distress syndrome, and those requiring invasive ventilation on ICU units... Delirium, especially its hyperactive motor form, will present significant additional challenges in the context of the Covid-19 crisis." European Delirium Association 2020

This conference focuses on the prevention, assessment and management of people with delirium. Through national updates and practical case studies the conference will equip you to spread the message that delirium is preventable, and develop your skills in the recognition, assessment and management of delirium. The conference will include case study sessions focusing delirium as a symptom of coronavirus and how this should be managed, delirium and dementia, delirium following surgery, delirium in the ICU and delirium at the end of life. There are also in depth sessions focusing on managing violent or aggressive behaviour in patients experiencing delirium and the link between delirium and pain.

The conference will also consider the January 2023 update to the Clinical Guideline on Delirium: prevention, diagnosis and management. In January 2023 NICE reviewed the evidence and made new recommendations on assessing and diagnosing delirium.
